

# TREETOPS PLAZA - SHOP AND WIN COMPETITION

## TERMS AND CONDITIONS OF ENTRY

- Information on how to enter and the prize, form part of the terms and conditions.
- The Shop and Win competition runs from 9am Friday 16<sup>th</sup> June 2017 to 9pm Saturday 30<sup>th</sup> September 2017
- All entries are to be placed in the barrel located in Centre Court.
